#### Sheriff

Melody Lyman stated the Sheriff's Office has rented a storage unit. Decker and Chip Crum has been working on the repairs to the jail. Mrs. Lyman presented a quote from Protec Security Services for the key card security system for the courthouse. Commissioner Kaminska moved and Commissioner Liebau seconded the motion to approve the quote from Protec Security Services, Inc. to install a new key card security system for the courthouse in the amount of \$8,415.80. Motion carried 3-0.

#### **Rural Fire**

Todd Winscher stated he and Nick Miller will be attending drone training class on October 10-12, 2022 in Salina. The Road & Weed Departments will pay for wages while Todd Winscher and Nick Miller are in training and the Rural Fire Department will reimburse the departments. Mr. Winscher has been working on the Kansas Firefighting Grant. If awarded the grant the funds will be used to purchase 33 sets of firefighting gear.

Noxious Weed

The department has been spraying in the mornings and working on dust control equipment in the afternoons.
