## Call to Order

Chairman Hendricks called the meeting to order at 1:00 p.m. Commissioners Kaminska, Hendricks and Liebau were all present as well as County Clerk Kerry Harrod and County Counselor Paul Dean.

## Minutes Approval

Commissioner Kaminska moved and Commissioner Liebau seconded the motion to approve the regular meeting minutes of July 11, 2022 as presented. Motion carried 3-0.

### Public Forum

The County Commissioners would like to congratulate all the 4-H kids and thank all the volunteers that made the fair possible.

### EMS

Ken Mitchell presented the monthly report for June. There were 17 total runs with total collections being \$14,100.74. Mr. Mitchell stated Unit #205 should be out of the shop by the end of the week. The new truck will cost a little more but it will be finished by the end of 2022.

## <u>Sheriff</u>

John Walker presented the monthly report for June. Sheriff Walker stated they have started cleaning out the evidence building by the Sheriff's Office. The antenna at the windfarm that was damaged in a storm has been repaired. The dispatchers will be covering some of Chautauqua County's shifts for a couple of weeks. Sheriff Walker stated six new bullet proof vests have been ordered and will be paid for by grant money and the Doug Hank's Memorial Fund. Deputy Bliss will be taking over the K-9 unit after she is certified. Commissioner Kaminska moved and Commissioner Liebau seconded the motion to purchase a K-9 transport insert for the dodge charger in the amount of \$2,695.00 to be paid out of the Sheriff's Equipment Fund. The jail repair should be finished the first week in August. Sheriff Walker stated Lauren Goyne was hired July 15, 2022 for the day dispatch position. There will be a radio training on Wednesday at 7:00 p.m. at the Cox Building. All dispatchers and deputies will be required to attend. Sheriff Walker said 4-County has shut down its crisis center.

## County Clerk

Commissioner Kaminska moved and Commissioner Liebau seconded the motion to hold the primary election canvass August 11, 2022 at 10:00 a.m. in the Commission Room. Motion carried 3-0.

### <u>Health</u>

Kandy Dowell stated 4-County would like to use the conference room the second and forth Monday of each month to see patients in. Mrs. Dowell will discuss rent amount and lease agreements with 4-County. Kristy Hanks was hired as a registered nurse and will start working for the Health Department August 22, 2022. Commissioner Kaminska moved and Commissioner Liebau seconded the motion to split Beverly Signer's wage 50/50 between the Health Department and the EMS Department effective August 2022 payroll. Motion carried 3-0.

#### Certified Sites

Discussion was had on the location of a possible site. It was decided to withdraw the application for the certified site and reapply at a later date.

## Letter of Appointment

Commissioner Kaminska moved and Commissioner Liebau seconded the motion to appoint Jessica A. Lee to replace Joan Murphy as Elk County's representative on the Section Eight Housing Board of Cowley County's Housing Authority. Motion carried 3-0.
